

## **Office of Infrastructure Protection (AXF)**

The Office of Infrastructure Protection (AXF) protects critical National Airspace System (NAS) infrastructure through assessments that continuously evaluate the threats, vulnerabilities, and consequences of potential security risks. Working with facility managers, classified material and information custodians, and security system design and implementation teams, our infrastructure protection specialists ensure that every staffed facility mitigates identified physical security risks and implements a facility level physical security program that protects the people, assets, and information critical to safety and operations of the NAS and the traveling public.

We provide program policy, guidance, and oversight and conduct facility security risk assessments and program compliance inspections for nearly 1,100 FAA-staffed facilities. Our Information Safeguards Program protects the Agency's classified national security information (CNSI) controlled, unclassified information (CUI), and ensures agency compliance with National Industrial Security Program requirements in classified procurements. We accomplish this by providing national policy, program oversight, and compliance reviews which align with federal regulations and departmental and agency policy. Our office also reacts to potential information breaches and assists information owners with required notifications and response and mitigation measures.

In support of this work, AXF is organized into the following six divisions:

- National Capital Infrastructure Protection Division (AXF-300)
- East Infrastructure Protection Division (AXF-400)
